- Executive Director Update
 - MARKET:
 - Downtown Vibrancy Fund:
 - o \$15,000 for FY24
 - \$5,000 for Spring Sip and Shop
 - \$10,000 for Spring Marketing Campaign
 - Hired Social Media Consultant who has started producing content.
 - Print Advertising: Focused on Rutland Magazine and Rutland Herald in the spring to promote spring Sip and Shop.
 - Upcoming Events:
 - 3/25: Poetry Walking Tour with Reading and Reception.
 DRP will host the event.
 - o 5/16: Spring Sip & Shop:

- Print advertising is complete
- Web Page is complete
- 17 downtown businesses signed up
- Need volunteers to help check people in. Two locations this year: DRP office and Merchant's Hall
- Friday Night Live
 - o 7/26, 8/16, 9/6 Tentative Dates
 - Contracts are being signed.
 - Plan to have 3 themed street parties with bands that support the theme, as opposed to trying to hire headliner bands. Will be important to create coherent and focused marketing push for these themes as they start getting promoted...

 - o Parklets: Installed 4/25 in collaboration with RRA and Rec
 - Flowers: Coming soon Potential for volunteer opportunities.
 - o Parking: Collaborating with Mayor and Rutland City.
 - Creating a one-page flyer on parking options downtown

 - DRP is focused on communication of the decisions made by the Parking Committee of the Board of Alderman

• Financial Update:

- Eddie gave update on FY24 to FY25 Roll Forward document that shows where the changes are to go from a budgeted deficit to a level budget for FY25.
- Eddie presented the draft of the FY25 budget and discussed the development of that budget in collaboration with Ed Bove and the DRP Finance Committee.
